ENG 1009S: Writing the Nation: a survey of the tension between the matter of history and the form of chronicle, juxtaposes historical texts read in pre-modern England with narrative poetry by Gower and Chaucer, plus early modern efforts to shape the past such as Spenser's *Ruines of Time* and Milton's *History of Britain* (2010-11, 2012-13, 2016-17 [summer]).

ENG 1550Y / 1552H: Chaucer: in his European context, read in tandem with the *Roman de la Rose*, Dante's *Inferno*, Boccaccio's *Teseida* and *Decameron*, illustrates how the English literary tradition is born out of the translation and adaptation of Continental models (1998-99, 2007-08, 2011-12, 2017-18)

ENG 1010Y / 1013H: Women in Medieval Literature: idealized images of women in Chaucer, Gower, Dante, and Petrarch, followed by works by women authors such as Margery Kempe, Julian of Norwich, Marie de France, Christine de Pizan, and Marguerite Porete (1999-2000, 2005-06, spring 2015).

ENG 1020Y / 1027H: Constructions of the Other in Medieval Literature: the depiction of excluded individuals or communities, particularly Jews and Muslims, in western Christian texts of the Middle Ages (1997-98, 2000-01, 2003-04, 2008-09).

ENG 1323H: Medieval Allegory: personification, typology, and figurative language in Middle English literature, with additional readings in the rich Latin and vernacular literature that influenced authors such as Langland and Chaucer (2006-07).

ENG 1017H: Body and Identity in Middle English Literature: embodiment, generation, and metamorphosis in several medieval texts, interpreted in the context of contemporary scientific, philosophical, and theological writings as well as modern somatic theory (2004-05, 2009-10).

ENG 1023S: Gower: the polyglot works of Chaucer's fourteenth-century contemporary. Special focus on the Middle English *Confessio Amantis*, with selections from Gower's Latin *Vox Clamantis* and Anglo-Norman *Miroir de l'Omme* (2001-02).

ENG 7000Y: Construction of Masculinity in Medieval Literature: the depiction of men, idealized and vilified, in a variety of western Christian texts. Normative sexuality in works such as the *Roman de la Rose* and the *Roman de Silence*; deviant sexuality in works such as *Clennesse*, the *De planctu Naturae*, and the *Pardoner's Tale* (reading course, summer 1998).

ENG 7000Y: Translating the Orient: nineteenth-century efforts to translate and transform Arabic and Persian poems and tales, and twentieth-century efforts to take stock of those efforts. Texts include Fitzgerald's translations of Attar and Khayyam, Burton's *1001 Nights*, Rushdie's *Grimus, Shame*, and *Haroun and the Sea of Stories* (reading course, summer 1999).

MST 3285S: Naming the *Rose*: A survey of late medieval intellectual history, centered on thirteenth-century Paris. Topics include neoplatonic philosophy, the hermeneutics of glossing, mythography, faculty psychology and sense perception, theories of knowledge, nominalism and sign theory (2005-06).
